


# **Tuition**



## Tuition and payment

When it comes to making a payment at Lynn University, there are a number of payment options available:

- 1) Cash
- 2) Check (paper or electronic)
- 3) Credit card
- 4) Bank wire (domestic / international)

It is important to note that a credit card payment can only be made online and will be subject to a processing fee of 2.75% for a domestic card and 4.25% for an international card. For online payments a debit card and credit card is not differentiated and as a result, a debit card is subjected to such a charge.

All tuition payments are due in full no later than the Friday before the term begins if your financial aid does not cover the full cost of tuition. All financial aid requirements should be finalized prior to the start of the term.

- Summer II payment due date is Friday, June 19, 2020
- Fall I payment due date is Friday, August 21, 2020,
- Fall II payment due date is Friday, October 16, 2020,
- Spring I payment due date is Friday, December 31, 2020,
- Spring II payment due date is Friday, March 5, 2021,
- Summer I payment due date is Friday, April 23 2021,
- Summer II payment due date is Friday, June 18, 2021.

#### Sources of finance

When it comes to resolving the balance due on a student account, a family has a number of options:

- 1) Self-pay: Submitting full payment by cash, check or bank wire.
- 2) Payment Plan: Lynn University offers a monthly payment plan that allows families to break the balance on account for a semester into five monthly payments (starting in July). You must enroll in this plan in order to participate. A \$35 application fee is charged by the processing company, Cashnet, when setting up the plan.
- 3) Financial Aid: Students can apply for financial aid at Lynn University. Scholarships, grants, and loans are all potential options available for students.
- 4) Any combination of the previous.

It is the student's responsibility to view tuition accounts (statements) periodically for charges, fees, financial aid disbursements and to determine if their financial aid (federal loans & institutional discounts) will cover the cost of their tuition (and other charges) prior to the start of each term. To view the tuition account (statement), submit payment and/or set up an authorized user (parent, spouse, family member), the student may do so once he/she create their MyLynn account (instructions below).

### Refund Policy for dropped classes

Prior to the date publicized as the first day of the term \*\*

During first week of the term (add/drop period)

100% 90%

On the first day of the term, the tuition is fully charged for all courses enrolled. If the course is subsequently dropped during add/drop period, the student will be entitled to a 90% credit on tuition on the dropped courses. After the add/ drop period, all tuition remains as assessed. There will not be any credit assessed on fees for course withdrawals. Students will receive 100% of the tuition paid if they drop the courses prior to the date publicized as the first day of the term. THERE IS NO REFUND AFTER THE FIRST WEEK OF THE TERM. There is no refund of Room after the first day of the term. Board refund is only available through 25% of the term in a case of a withdrawal from the university.

#### Undergraduate Online/Graduate Withdrawal

Withdrawals from the online and the graduate division programs or classes must be accomplished through the Office of the Registrar, and are only permitted through the sixth (6th) week of a 7 week term or the seventh (7th) week of an 8 week term. It is the student's responsibility to properly file a Request for Withdrawal form from the Registrar's Office. This will establish the day to which the University refund schedule applies. It is also the responsibility of the student to make a written refund request to the Student Financial Services Office before refunds will be made.

When a withdrawing student has been awarded financial aid and the student withdraws prior to completing 60 percent of the term, and if Title IV financial aid has been used to pay all or any portion of the charges, the financial aid program funds will be reimbursed to the appropriate agency in accordance with a formula required by federal regulations.

Unearned Title IV funds will be returned to the Title IV programs based on the number of days not attended. The order of refunds will be: Federal Direct Unsubsidized Loan, Federal Direct Subsidized Loan, Federal Direct PLUS Loan, Federal Direct Grad PLUS Loan, Federal Pell Grant, Federal SEOG and other Title IV aid programs. Students enrolled in only three credits each in the evening term will have a Title IV calculation computed on two terms.

If a student withdraws at any time during a semester, all Lynn University grants and scholarship funds will be prorated to the university accounts. This policy may result in a financial obligation that is payable to the university at the time of a student's withdrawal.

Please be aware that classes should be dropped prior to the start of the term. Once drop/add begins, you will be responsible for 10% of the tuition cost on any class that is dropped and not replaced during the drop/add period of that term
